This is to inform you that the Company and its Directors, *inter-alia*, Mr. Atul Hirji Maru (Joint Managing Director), Mr. Hiren Uday Gada (WTD & CEO) and Mr. Amit Haria (CFO) have received Show Cause Notice dated 02.08.2024 ("**said Notice**") under Sections 74 (1) and 122 of Central Goods & Services Act, 2017 ("**CGST Act**") read with corresponding Maharashtra Goods and Services Tax Act, 2017 and Section 20 of Integrated Goods and Services Tax Act, 2017 from the Office of the Principal Commissioner of CGST & CX, Mumbai – East.

At the outset, nothing contained in the said Notice shall be deemed to be admitted by the Company in any manner whatsoever. The Company *inter-alia* does not accept the tax liability and the penalties set out under said Notice. The Company is in the process of reviewing and evaluating all the available legal recourse to challenge the same. The Company will be filing appropriate response to the said notice within the prescribed timelines.
